

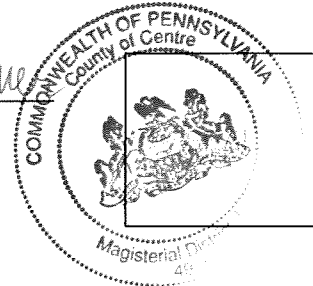

**AFFIDAVIT of PROBABLE CAUSE**

CI 4099-18, hereinafter referred to as "CI" was developed as an individual who could assist law enforcement with drug investigations. CI expressed Ci's willingness to assist law enforcement by conducting controlled buys under the compliance and control of the Centre County Drug Task Force. CI is familiar with an individual known to CI as Seth Witherite, hereinafter "Witherite". CI has purchased crystal methamphetamine and other controlled substances from Witherite on multiple occasions and knows Witherite to be an individual that routinely sells controlled substances.

CI had a phone and text conversation with Witherite wherein Witherite stated he could sell CI one (1) gram of crystal methamphetamine to CI for the price of \$100.00. CI provided a mobile number that CI uses to contact Witherite. A records check confirmed the phone number as being utilized by Witherite.

I utilized RMS to obtain a middle name and date of birth for Witherite and observed numerous prior entries associated with his name. CI provided me a picture of Witherite via social media. I located a Pennsylvania Driver's License for Witherite and confirmed his identity with the CI as the person known to him as offering crystal methamphetamine for sale.

10/30/2018

Buy #1 details the controlled buy of 1 gram of crystal methamphetamine on 10/30/2018. CI purchased the crystal methamphetamine from Witherite via Bradley Bortner for \$100.00.

At 1:15pm CI contacted me and explained a recent phone conversation with Witherite, wherein Witherite agreed to sell CI a gram of crystal methamphetamine for \$100.00. The buy was set to occur at Witherites residence located at 104 Moore St. Julian, PA 16844.

At 2:00pm Det. Federinko picked up the CI and transported CI to PTPD.

At 2:10pm Det. Federinko, CI, Det. Paul, and I arrive at PTPD. CI is searched and found to be free of currency, controlled substances, and contraband.

At 2:20pm Det. Federinko provided CI with \$100.00 in pre-recorded buy money.

At 2:33pm detail departs PTPD to conduct the controlled purchase. CI travels with me in UC vehicle in route to Witherites address. At 3:05pm detail briefly meets at Wingate Sheetz and depart for Moore Street in Julian.

At 3:16pm Det. Federinko and Det. Paul establish surveillance in the area of Moore Street. CI and I arrive at 104 Moore Street. Julian, PA 16844

At 3:16pm CI exits UC vehicle and knocks on the door of 104 Moore Street. I observe as Witherite answers the door and CI and Witherite enter the residence.

At 3:21pm CI and Witherite exit the residence. CI walks up to me at UC vehicle and explains asks me to give Witherite a ride to Pleasant Gap to "pick up". CI and Witherite enter UC vehicle.

At 3:22pm CI, Witherite and I depart Moore Street in route to Danielle Drive, Pleasant Gap, PA. Det. Federinko and Det. Paul follow and maintain surveillance of UC vehicle.

At 3:38pm we arrive at Pleasant Hills apartment complex located on North Danielle Drive, Pleasant Gap, PA. Witherite directs me on to Kiara lane and tells me to park near the bicycle rack. I park at the bicycle rack CI and

Witherite exit the vehicle and walk toward the 100 block apartments of N. Danielle drive. I observe as CI and Witherite approach the apartment. Witherite then enters the apartment and CI stays outside.

At 3:48pm CI and Witherite walk back to my vehicle and enter.

At 3:51pm we depart Pleasant Hills apartment complex in route back to Witherite's residence on Moore Street. Det. Federinko and Det. Paul follow behind UC vehicle.

At 4:05pm Witherite asks if I could stop at the Wingate Sheetz. I stop at the Sheetz located at 820 South Eagle Valley Road and park on the south east side.

At 4:06pm CI and Witherite enter the Sheetz store.

At 4:14pm CI and Witherite exit the Sheetz store and enter my vehicle.

At 4:18pm we return to 104 Moore Street. Julian, Pa 16844 and Witherite exits the vehicle and enters the residence. CI immediately hands over the small Ziploc bag of suspected Crystal Methamphetamine he purchased from Witherite. We depart Moore street in route back to PTPD. CI explained that while at the Pleasant Hills apartment complex CI handed Witherite the buy money. Witherite then knocked on the door of 100 North Danielle Drive apartment 317. A male known to CI as Brad Bortner answered the door. Witherite entered the apartment while CI stayed outside of the apartment door. Witherite exited the apartment with the Ziploc type bag of crystal methamphetamine and handed it to CI. CI explained conversations had with Witherite regarding Bortner being his supplier of methamphetamine.

The detail returned to PTPD station and at 4:48pm CI was searched in a secure area and found to be free of currency, controlled substances and contraband.

At 5:45pm I conducted a field test on the suspected Crystal Methamphetamine, which consisted of one 2.5"x1" Ziploc type bag containing white/clear crystal methamphetamine, which tested positive. Evidence was packaged and submitted accordingly, maintained at PSUPD.

Bortner's identity and address were confirmed through information received from Spring Township Police Department.

Your affiant is Detective Robert Ruggiero of the Penn State University Police Department. Your affiant has been so employed since November of 2016. Prior to Penn State University your affiant was employed as a Detective for the Bellefonte Borough Police Department. Your Affiant began his law enforcement career in November of 2004 at the Baltimore City Police Department and received initial training at the Baltimore City Police Academy. Your affiant has been an active member of the Centre County Drug Task Force under the auspices of the PA Office of the Attorney General/Bureau of Narcotics Investigation. Your affiant has the authority to investigate and arrest persons for violations of the Controlled Substance, Drug, Device and Cosmetic Act. Your affiant has received training relative to drug investigations from the Baltimore City Police Department, PA Office of Attorney General/BNI, the DEA, FBI, Pennsylvania National Guard, Pennsylvania Narcotics Officers Association, Pennsylvania State Police, PATCtech and numerous private firms. Your affiant has worked in specialized units and enforcement teams to include the Baltimore Police Department Firearm Interdiction Unit, Specialized enforcement team (SET), and Flex teams. Your affiant has conducted and/or been involved with numerous investigations, including but not limited to homicide, attempted homicide, robbery, burglary, assaults, and incidents employing surveillance, use of confidential informants and undercover operations.

Your affiant has operated in an undercover capacity and has purchased controlled substances as part of his role as a drug investigator. Your affiant has conducted numerous investigations and prepared and executed numerous search warrants for both controlled substances and other related incidents. Your affiant is familiar with the methods in which drug dealers package drugs for distribution for street level use and or sale. Your affiant is familiar with the methods in which drug dealers operate distribution rings. As a result of your affiant's training and experience your affiant is familiar with the clandestine manner in which drugs are used, packaged, delivered and sold.


Your affiant has been involved in over 500 drug related investigations, applied for and/or executed more than 50 search warrants, supervised more than 100 controlled deliveries, seized large quantities of controlled substances and has charged individuals for violations of the Controlled Substance, Drug, Device and Cosmetic Act; specifically, for the delivery of controlled substances. Your affiant has interviewed more than 500 people who were personally involved in the trafficking of controlled substances. As a result of these interviews and training your affiant has become familiar with and knowledgeable in the methodology and business practices used by drug dealers to include concealment, packaging, prices for which drugs are sold, terminology, and methods of record keeping. Your affiant has also become familiar with and knowledgeable in recognizing behavioral patterns of drug dealers and interpreting coded language used by drug dealers.

Your affiant has received mobile device training from PATCtech and is aware that drug dealers commonly employ mobile phones/mobile devices/cellular phones/smart phones to set up and conduct illegal drug deals. Your affiant knows that text messages, application messages and data, call logs, photographs, geographical data, time stamps, phone contacts and other pertinent data are stored on mobile phones/mobile devices/cellular phones/smart phones utilized to conduct illegal drug sales. Your affiant knows that the above listed information available on mobile phones/mobile devices/cellular phones/smart phones can sometimes be retrieved even if deleted from the device by the user. Your affiant has viewed data derived from said devices and has corroborated said data to drug deals and criminal activity.

At this time, based upon the investigation set forth in this Affidavit of Probable Cause, your affiant believes probable cause exists to charge Witherite and Bortner accordingly. All events occurred in Centre County Pennsylvania.

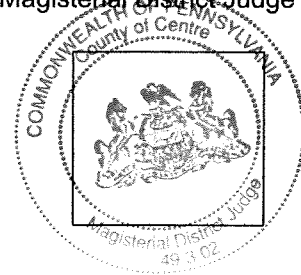
