We've updated our pricing for 2027 and are offering two options:

- **PREPAY**, available through end of day (E.O.D.) **December 23, 2026**
- **PAY-PER-CAL**, available after that date

Please note: **PREPAY does not require early payment**, only submission of your completed form by **E.O.D. December 23, 2026** to secure the discounted rate. **PAY-PER-CAL** submissions must be received by **E.O.D. December 30, 2026** to avoid any disruption in your calibration services. After that deadline, we'll begin adjusting schedules based on received calibration forms. Be sure to reference these details when completing your 2027 Calibration Form.

Information to help with any questions you may have regarding the calibrations:

ON-SITE CALIBRATIONS

- An On-Site Fee of \$150 will be charged for each stop.
 - The host department will be invoiced in the same manner as their calibrations (Prepay or Pay-Per-Cal) unless otherwise instructed.
- Tentative calibration dates are included with your certificates. Final dates and times are emailed via MailChimp two weeks prior to service. You can sign up multiple recipients—just click **"Sign up for Calibration Reminders"** on our homepage under **Reminders & Announcements**.

CALIBRATIONS AT YCG's FACILITY

- No fee charged; appointments should be scheduled in advance to alleviate your wait time. We may not have a technician working in the shop, so appointments are encouraged.
- We will email the Primary Speed-Timing Contact prior to your certification expiring to let you know an appointment needs to be scheduled.

MAIL IN EQUIPMENT TO YCG

- You'll be invoiced at our Pay-Per-Cal rate plus a \$15 tracked shipping fee for small packages or thick envelopes. Return shipping may be included with your equipment if preferred.
- Accounts not in good standing (see Payment Policy) must pay before services are performed. Equipment left unpaid at YCG for over 30 days will be surrendered.
- We will email the Primary Speed-Timing Contact prior to your certification expiring to let you know an appointment needs to be scheduled.

Submitting your calibration form is essential to maintain preferred customer status. Active calibration customers receive discounted service pricing, 5% off products (website code available), and Net-30 payment terms. Without a current calibration form on file, all products and services will be due upon receipt.

PAY-PER-CAL: You will be invoiced for the calibration(s) plus \$15 S/H unless a return shipping label is provided. See YCG's Payment Policy regarding timely payments and accounts in good standing.

We provide this service at your station* for your convenience. Schedule an appointment for certification at our Williamsport location or mail in your equipment to save the on-site fee.

***\$150 On-Site fee per stop will be added unless \$1500 minimum per stop is met.**

You will receive an email through our Mailchimp account 2 weeks prior to each calibration with your scheduled time and the scheduled YCG technician's name & phone number.
